Good morning gentlemen,

As I think you know, a neighbor has filed an appeal of the BOA's approval of the design for the new house on Lisbon. Since the BOA approved the design, we would normally begin reviewing the construction drawings in anticipation of issuing the building permit. However, Section 3-606 of the Zoning Code says that "an appeal shall stay all proceedings in the matter appealed from until the final disposition of the appeal by the City Commission or other Board with jurisdiction". The developer has requested that we proceed with the building plan review, at his risk and with the understanding that a permit will not be issued unless and until the appeal is decided in his favor. Craig, do you think this Zoning Code provision prohibits us from reviewing the plans? If not, then I'd like to know Bill's thoughts on proceeding with the review. If you need more information on the particulars of this case, I'd be happy to discuss it with you.
